14 — Selection Method(s) and Criteria

In accordance with Article 9 of Law No. 55/2025 of April 28 and Article 7 of Ordinance No. 485-A/2025/2, of August 28.

- 14.1. The recruitment processes for researchers aim to evaluate the scientific capacity and merit of candidates in the different aspects that comprise the set of functions to be performed, and should consider:
- a) The scientific and professional trajectory, especially the professional research experience in the scientific area or areas of the competition;
- b) The quality and relevance of scientific production;
- c) Contributions to science, the scientific community and society, in particular:
- i) The generation of new ideas, tools, methodologies and knowledge;
- ii) The training and development of careers and the creation of teams, as well as involvement in networks and partnerships, both national and international;
- iii) The capacity to raise funds within the scope of competitive programs and projects, both national and international;
- iv) Pedagogical experience, when applicable;
- v) The scientific supervision of internships and undergraduate projects, master's dissertations and doctoral theses integrated into the respective areas of specialization, when applicable;
- vi) The social, cultural and economic impact of the scientific activity developed; vii) The application, valorization, and transfer of knowledge, including in the technological dimension, when applicable;
- viii) The transfer and dissemination of knowledge;
- ix) The organizational and program management of science, technology, and innovation.
- 14.2 Candidates holding a doctorate in the scientific area of the reference to which they are applying and a favorable opinion from the Independent Commission appointed for IPMA, I.P., will be admitted on absolute merit;
- 15 Scientific Merit Classification System:
- 15.1 —
- a) Scientific and professional career path, especially professional research experience in the scientific area(s) of the competition; (PCF) 10%
- b) Quality and relevance of scientific production; (QPC) 10%
- c) Contributions to science, the scientific community and society (CCCS), in particular:
- i) Generation of new ideas, tools, methodologies and knowledge; 10%
- ii) Training and career development and the creation of teams, as well as involvement in networks and partnerships, both national and international; 10%

- iii) Ability to raise funds within the scope of competitive programs and projects, both national and international; 10%
- iv) Pedagogical experience, when applicable; 10%
- v) Scientific supervision of internships and undergraduate projects, master's dissertations and doctoral theses integrated into the respective areas of specialization, when applicable; 10%
- vi) The social, cultural, and economic impact of the scientific activity developed; 10%
- vii) The application, valorization, and transfer of knowledge, including in the technological dimension, when applicable; 10%
- viii) The transfer and dissemination of knowledge; 5%
- ix) Organizational and program management of science, technology, and innovation. 5%
- 15.2 A candidate is considered approved on absolute merit if approved by an absolute majority of the voting jury members.
- 15.3 Regarding scientific merit, each jury member performs their evaluative exercise, scoring each candidate in relation to each parameter, on a scale of 0 to 100 points.
- 15.4 The Final Result (RF) of the evaluation of each candidate by each member of the panel is calculated using the weighting formula of the various parameters:

RF =

PCF*10%+QPC*10%+CCCSi*10%+CCCSii*10%+CCCSiii*10%+CCCSiii*10%+CCCSiii*10%+CCCSiii*10%+CCCSiii*5%+CCC

- 16 The list of admitted and excluded candidates and the final result of the competitions, after approval, will be notified to the candidates and published in the Recruitment area of the IPMA, I.P. website.
- 17 There will be a hearing of interested parties, in accordance with the Administrative Procedure Code, after the application of the selection methods and before the final decision is made. Candidates who are excluded will be notified preferably by email.
